

## Why Did This Spring's "100 Year" Rain Cause Flooding?

#### Come to our General Meeting Tuesday, Oct 29, and find out!

People frequently remark about our picturesque area and how surprisingly "hilly" it is. And a number of private ponds within our territory provide hours of delight for children and adults alike, as well as the water-loving creatures we all enjoy in our semi-rural, unincorporated area.

Some of us have lived in the same house for many years, and even during heavy "100 year" rains have never had any flooding. Our area has had very little concrete or blacktop added over the years. So after this spring's "100 year" rain, some people were surprised by the flooding that took place. The following questions emerged:

What changed?

Did this "100 year" rain have more inches coming down faster?

Has a nearby pond gradually filled with silt?

Is there an old underground drain pipe that is now clogged? (Our area used to be farm land!)

Did the flooding come from only one nearby property?

Or did it begin further away, flooding a nearby property, which in turn flooded another property?

Or did a river, creek or stream overflow?

Where is the highest point in our West-Win territory, and how high is it?

The lowest point?

Come to our fall General Meeting on Tuesday evening, October 29, and hear Gregory Phillips, PMP, from DuPage County Public Works, give an overview of our entire area, complete with topographical maps. Gregory will be joined by Sarah Hunn, Senior Project Engineer in Stormwater Management. They will also address funding that might be available for such things as:

Assessing problematic runoff from a nearby property,

Dredging ponds, and

Installing or repairing major conduits for future heavy rains.

The presentation may also address such questions as:

Am I free to fill in a "ditch" along the side of my property line? I don't \*think\* it will cause any flooding for anyone else...

Several years ago someone filled in a ditch, and ever since then I have had annoying flooding in heavy rains. Are there services available to me as a taxpayer to have an assessment made?

For flooding near the river, would it help to install an additional (or larger) culvert to handle water runoff to the river?

The street in front of my house was closed off due to deep water, and my basement had major flooding. Am I eligible for funding for cleanup and repairs?

Would a deeper ditch along some roads help avoid flooding in the future? If so, does the County evaluate that and the Township install the ditch?

Does the County, or other governmental agency, have funds available for dredging a pond, repairing or enlarging drains, etc.?

What is the difference between a <u>de</u>tention pond and a <u>re</u>tention pond?

What things can residents do to prevent flooding?

If we experience run-off and ponding/pooling in a heavy rain, do I need to be careful walking through the water? If so, what are the risks of walking through the water?

Bring your questions to the meeting on Tuesday evening, Oct. 29. If possible arrive <u>30 minutes</u> <u>early</u> to study the topographical maps on display, See the cover for location and time.

## **Highway Commissioner Retired**

Joe Jedlovec, Jr. has retired after 24 years with the Winfield Township Road District. Many of you will remember him, having met him on the road in front of your house or at one of our West-Win meetings. Joe could sometimes be seen filling in for absent team members doing hands-on work to help keep our roads in shape.

If you ask Joe to go fishing with you, he might finally have the time to do it, now that he is retired as Highway Commissioner of Winfield Township Road District. And fishing is something he's enjoyed all his life while growing up right in and near the West-Win area. He knows a lot of the wooded areas and waterways by heart from years of first-hand exploring. If Joe has to say no to your fishing invitation, it might be because he is busy with grandfathering activities.

At one West-Win meeting, Joe explained that it took 5 hours to make one circuit of snow plowing. Some of us were fortunate to be near the beginning of the circuit, and found, on the way to work, that our township roads were plowed long before the county or state roads. Those near the end of the circuit still received good service.

Joe was the President of the Township Highway Commissioners of DuPage County, who met to coordinate with each other. The relationships developed during the meetings of this group were helpful later for reciprocal aid after a storm.

If you're new to the area, you might not already have the latest Township Road District Homeowners' Handbook for 2013. This handy booklet has pictures and drawings to help you know where to place your mailbox, when and how leaves and brush will be picked up, when and how to obtain permits and other helpful information. The booklet was created for you by Joe and his team.

#### **Prevent a Wet Basement**

Several Ways! Many of them Free!

Why do some basements stay bone dry after a heavy rain, while others get water? A few simple techniques can sometimes make all the difference. Don't wait until after the next heavy rain to learn about them as you mutter to yourself, "If only I'd known"! Instead, be proactive and invest 5 minutes to get armed with some tips available at our next General Meeting, Oct. 29.

We also hope to have available a list of what you can do in case of an area-wide flood that does affect you or a friend or relative. Sometimes the professional "aftermath" services are booked for days; and time is of the essence. These tips would help you through that scenario.

After the "100-year" rain this spring, a number of people were wondering about taking out flood insurance, and there was a lot of misinformation and speculation being bantered about. One of the elusive points was what actually constitutes a "flood" from an insurance point of view. We hope to



have available at our meeting a long-time specialist who mucks around in the "aftermath" of flooded basements, assessing damage and cause. This is one professional you hope you'll never have to meet in your own home!

## Fellow homeowner shares advice from experienced plumber

Over time, one of our low flow toilets became increasingly sluggish then finally quit flushing altogether. We called the plumbing company that installed the toilets and they sent a plumber out to investigate the problem. He asked for a five gallon pail, filled it with water and poured it briskly down the toilet. After a moment or two of hesitation, the toilet spontaneously went into a full power flush! Two or three successive normal flushes, using the flush handle, worked perfectly!

What happened? Here was the plumber's explanation: Most quilted and two-ply toilet paper is manufactured with a type of "wax" to hold it together. This "wax" prevents it from dissolving quickly and completely. With the limited amount of water available for each flush, this undissolved paper may not be completely propelled along the horizontal drain line and begins to build up in the elbow underneath the toilet discharge, eventually resulting in poor flushing and finally a plugged line.

The preventive solution is to use Scott Extra Soft toilet paper. This product is manufactured without "wax" and disintegrates rapidly when placed in water, without breaking down during use. The result is a complete flush without toilet paper buildup in the elbow. An additional benefit for our area is that it is safe for septic systems.

We made the switch and have had no more flushing problems. We hope our experience and the simple solution may save you an unnecessary plumber's bill.

Editor's note: Using Scott 1000 or Scott Natural should also work for preventing clogging.

A faithful volunteer who enjoyed working consistently in the background for 9 years, on your behalf, passed away this summer. (His family prefers to keep him anonymous.)



#### SAVE \$5 BY PAYING YOUR 2014 MEMBERSHIP DUES NOW


If you pay your dues by the end of October, you may deduct \$5. After October 31, dues are \$20 per household once a year - which is still a bargain!

**Help with newsletter mailings** Needed twice per year, usually the first weekends in April and October. Join others as the newsletter is inserted into envelopes and stamps and address labels are applied.

**Greeter for General Meetings** Needed twice per year, usually the 4th Tuesday evening of April and October. Welcome people at the door and direct them to the various tables for sign-up, dues payment, and collection of handouts.

## **Fall Meeting Will Be at Cantigny Park**


Cantigny Park has again offered West-Win the Auditorium in the Visitors Center for the Fall 2013 General Meeting while the Winfield Library undergoes renovation.
