

The site is still a work in progress as we are continually adding newsletters with the intention of having all of our newsletters available on the website. This website has been under development since Comcast pulled the plug on our old website in October, 2015. In the meantime we have migrated our membership database from our webmaster's personal computer to one hosted on the web so that our officers and board can have access to current information without requiring assistance from our technology team. We also went through a period of transition when our previous webmaster passed away and a new one had to get up to speed with all things technological.

We had a number of meetings of the Technology Committee of the Board to identify requirements for our new website, found an Internet Service Provider (ISP) to host our website, database and email services, and sent our website specifications to several potential developers in order to assess how much it would cost to do the things we wanted to do.

The Technology Committee and then the full Board has been testing and tweaking the website all summer and finally got to the point where it was ready for prime time – that is you, our members – in late August.


#### **FOLDING A FITTED SHEET**

The problem in folding a fitted sheet is the bunched up areas produced by the elastic band around its perimeter. The secret to folding it up neatly lies in choosing the places to fold such that the bunched up areas, particularly at the corners, wind up lying side by side, not randomly overlapping each other. When this is done, the overall thickness is the same everywhere, and you have a neatly folded package. In the pictures that follow black circles are shown over each of the thick corners so you can see where they lie before and after each fold.


The folding principle is very simple, and can be done by one person, but two people make the job faster and easier.

In Picture 1 the sheet is laid out on a bed with the underside up. The circled corners are obvious in this initial picture, but become less so in later shots where they lie under folds.


The first fold is shown In Picture 2. One end is brought up exactly half way to the other end. The second fold (Picture 3) brings the far end up over the previously folded area, and the sheet has now been folded in thirds. As you can see, what were opposite corners, now lie next to each other.










The next two folds (pictures 4 & 5) now duplicate folding the sheet again into thirds in the opposite direction. As the circles show, all four corners now lie next to each other.





The last two folds (Pictures 6 & 7) just double the sheet over in half (not in thirds) in each direction. As the multiple circles show, this results in all 4 corners stacked on each other vertically. Remember that all the bunched up edges also now neatly lie on top of each other resulting in a nice, neat final package that's easy to store.

#### HELP WANTED: ASSISTANT WEBMASTER / DATA BASE ADMINISTRATOR

We are seeking an individual with good technical knowledge to assist our Webmaster / DBA in the maintenance of our website and membership database.

Typical tasks will include investigation and correction of anomalies in the database, producing periodic database extracts wanted by board members, maintaining semi-annual updates of the 'flattened' Excel version of the database which will be available to Board members from the website and other similar tasks in coordination with the webmaster / DBA. Occasionally, generating a mass email to the membership will be done if the Webmaster / DBA is not available. Members of the Board perform routine database entry tasks and maintain the Newsletter and News content of the website.



A requirement for the position is fluency in the creation of SQL queries in a MySQL environment, and being very comfortable with Excel. A major plus would be familiarity with Crystal Reports, which is used to produce our semi-annual membership letters and meeting roster. CR is also used to create information that is used in the development of the Excel version of the database mentioned above.

Time frame: various times throughout the year. Time commitment and need will fluctuate, but generally not exceed 4 hours in a month. This is not a Board position so attendance at Board meetings is not required unless a technology issue is on the agenda and the Webmaster / DBA is not available. There may be periodic meetings of the Technology Committee of the Board, but those are scheduled with the input of all attendees and are very infrequent, especially now that the new website is available.
